- The value of the SAR for Mr. McMunn was calculated as follows: (187,860/.65) - 187,860 (Appreciation/1 - Tax Rate) - Appreciation "Appreciation" equals the amount by which the fair market value of SAR's related shares at the time the related option is exercised exceeds the price paid for the share, and "Tax Rate" equals the optionee's tax rate as determined by the IRS Tax code at the time of exercise.
